

ACCOUNTABLE CARE ORGANIZATION OF PENNSYLVANIA, LLC

Pursuant to the interim final rule addressing “Waivers in Connection With the Shared Savings Program,” ACO-PA identifies the following arrangements, for which waiver protection is sought.

1. Integrated Provider Performance Incentive Plan Version 2.0, an accountable care model designed by Independence Blue Cross to incent and reward the delivery of superior quality and cost-effective care (“IPPIP”).
2. Small Incentive Payment Arrangements, DVACO distributes incentive payments of under \$200,000 it receives from payers other than Medicare to its participating providers in accordance with DVACO's MSSP Distribution Model to the extent such model can reasonably be applied to such incentive payments and otherwise as consistent with the purposes of the MSSP (“SIPA”).
3. Care Coordination Support, DVACO, directly and through its member Clinically Integrated Networks, provides support for care coordination resources embedded in its participating providers’ practices (“CCS”).
4. PCMH Support, DVACO, directly and through its member Clinically Integrated Networks, provides support for the transformation of its participating providers’ practices’ transformation to a patient centered medical home (“PCMH”).
5. Patient Experience Surveys, DVACO provides funding for surveys of patient experience using nationally recognized tools and processes to its participating providers (“PES”).
